## CALL TO ORDER:

## PRESIDENT'S REPORT:

Welcome and introductions.
Tim talked about BYSA and raising money through the meat raffles, bingo and pull tabs. He told the sports how important it is that Gily's continues to be a successful business. We will hold a golf tournament again this year. We would like it to be bigger than last year's with the potential to raise more money. We would like to see each sport sponsor a hole.

## SECRETARY'S REPORT:

April minutes were read by Teresa.
M/S/P (Mike/Angie) to approve the minutes pending the correction to the refund amount stated in the Gambling report.

## TREASURER'S REPORT:

Mike handed out the Balance sheet and the P \& L Statement as of 12/31/10.
Tennis and Volleyball have accounts, but they do not show up on the report because he has not gotten any statements from the bank for those two sports.
We had $\$ 90,647.00$ in Total Assets. $\$ 3250.00$ of this is the Jaycee's scholarship fund. The P \& L statement shows the individual sports' incomes and expenses. The organization's total income was $\$ 231.067 .48$
The total expenses for the organization were $\$ 245,066.19$.
There was a Net Loss of $\$ 13,997.22$.

## GAMBLING FINANCIALS: (Sherry Hubbard)

The April P \& L and Balance sheets were handed out.
The P \& L Previous Year Comparison was handed out.
Because Gily's was closed in April, we made $\$ 450$ on one meat raffle.
Our checking account balance is $\$ 2400$.
Sherry encouraged all the sports to support youth sports by attending the meat raffles,
bingo and pull tabs. Without Gily's, BYSA would have no income.
We will transfer our storage unit from Clear Lake to Becker.
Sherry thinks she may have sold the safe.

## OLD BUSINESS:

## NEW BUSINESS:

The individual sports reported on their participation and fundraising.
Boys' Lacrosse - Brandon Kent. They just started up . There are 31 boys, grades 6 - 11 . They have a middle school team and a JV team and are considered a club sport. They will be looking for more funds to cover their start-up costs.
Swimming - Valerie Hanson. They have 45 girls, grades $7-12$. They had a very good season and they are involved in a few fundraising activities.
Becker-Big Lake Blue Line Club - HS hockey - Lori Molus. They had 24 varsity players. Becker High School is trying to cut their program. There is a meeting set up for May 12 (with Big Lake and Monticello) to discuss this. There is the possibility of them becoming self-funded.
Wrestling - Troy Berning, Becky Andres - They had 90 youth ( $\mathrm{K}-6$ ) in their "feeder" program for MS - Varsity. The youth had a very successful season, doing quite well at their tournaments both as teams and individually. They help fund summer camps and Rumble on the Red. They have "Becker Sundays" open gym and youth tournaments as fundraisers. This year they will be sponsoring a two day "Gopher Camp" as well.

Soccer - Lisa Peterson. They had 6 traveling teams, ages 9 - 14 and one boys' U10 team. They are down to 5 traveling teams. This is their second season as traveling teams. They have had some problems with vandalism at the BAC (ripped goal nets...). They are currently doing an apparel fundraiser.
Diamond Club - Brian Kolbinger. Their numbers are down slightly. They have 180 youth players and 150 junior players. They are self-sufficient cost-wise. They are working with the city for use of the concession stand.
Gymnastics - Sherry Hubbard. They support girls youth through high school. Their program is putting Becker on the map as far as gymnastics is concerned. They had a very successful season! They currently have three junior teams ( 2 are competitive) plus 100 youth in the community ed program. This year they replace their floor with help from BYSA and their own fundraising.
Youth Football - Mike Walberg. They had $746^{\text {th }}$ graders ( 4 teams) and $934^{\text {th }}$ and $5^{\text {th }}$ graders ( 5 teams). Their numbers are dropping but they still have the lowest fees in the league. They are also experiencing some changes in their league make up.
